## ASSUMPTION OF RISK, RELEASE OF LIABILTIY AND INDEMNITY

The above Horse Owner (also referred to herein as "you") has agreed to furnish the above horse ("Horse") to perform with youth exhibitors in equine competition events at the 2012 International Youth World Cup to be conducted in Kreuth, Germany, July 21 – 28, 2012 ("Youth World Cup"). You acknowledge and agree to the following:

You are not obligated to transport their horse(s) to and from the Youth World Cup, but can donate cost of transportation or actual transportation if you so wish. Otherwise the local affiliate and FEQHA will pay for the transport. If you transport the Horse yourself, you assume the risk of personal injury yourself, injury to the Horse or property damage incurred while travelling to and from the Youth World Cup.

You accept the Youth World Cup facility and grounds on an "as is" basis, including, but not limited to, the arena, the stalls and the alleyways. You understand the nature of the Youth World Cup activities and that such activities include, but are not limited to, youth exhibitors and other participants riding and handling the Horse both prior to and during equine competition events ("Activities");

You warrant and represent that both as to training, disposition and health, the Horse is suitable to safely participate in the Activities. Further, if you are furnishing tack or equipment, the condition of the tack and equipment is suitable to safely allow individuals to participate in the Activities.

You fully understand that the Activities include, but are not limited to, "inherent risks of equine activities" that may result in your injury or death (if you are at the event), injury to or death of the Horse or damage or loss to property (including, but not limited to tack and equipment) (collectively "Risks"); that such Risks may be caused by an exhibitor's action or inaction, the action or inaction of others participating in the Activities, the condition of the premises at which the Activities take place, and/or the negligence of the "Releasees" named below.

You fully accept and assume all such risks and all responsibility for costs and damages you incur as a result of your or your horse's participation in the activities. You hereby release, discharge, and covenant not to sue AQHA, FEQHA, the owners/lessors of the youth world cup facilities or their respective administrators, directors, agents, officers, members, independent contractors, corporate partners, volunteers, and employees (each considered one of the "Releasees" herein) from liability as to your injury or death, injury to or death of the horse or property damage or loss occurring as a result of your or your horse's participation in the activities or caused or alleged to be caused in whole or in part by the negligence of the Releasees.

You agree to indemnify, hold harmless and defend Releasees from liability, whenever or however arising, from all third party claims, demands, causes of action, suits, judgments, liabilities, costs and expenses arising out of your negligent act(s) or omissions during or related in any way to the Activities or any misinformation or misrepresentations made by you in this Agreement or on the Horse Donor Form.

PLEASE NOTE THAT FEQHA HAS OBTAINED INSURANCE COVERING UP TO 15.000 € PER DONATED HORSE (PLUS SOME FURTHER COVERINGS) DEPENDING ON VARIOUS POTENTIAL SCENARIOS DERIVING FROM THE TRANSPORT OF AND PRESENCE OF THE HORSE AT THE YOUTH WORLD CUP. SUCH INSURANCE NAMES FEQHA AS AN INSURED AND HORSE DONORS AS ADDITIONAL INSUREDS
